Last year, many businesses and organizations came to a screeching halt as COVID-19 wreaked havoc in our communities. Local nonprofits faced similar challenges; some were even forced to close, not only having to stop supporting people in need but also laying off their staff. Other nonprofits responded to extreme demand for services, expanding and safely altering their programming to meet the most critical needs in the community. Rochester Area Foundation was honored to work side by side with these organizations, ensuring the continued safety and security of our community through nonprofit success.

For over 75 years, Rochester Area Foundation has been working to build partnerships in our community. 




We are proud to steward financial gifts from individuals, nonprofit organizations, and businesses within our portfolio.

Coy Family

With the loss of their son Wyatt at age 18, Matt and Michelle Coy and their daughter Morgan found that this tragedy brought a new purpose to their family. "Wyatt had a belly laugh that would embrace an entire physical space with joy," remembers Michelle, "and once he got going the whole room had to join him." The Coy family was overwhelmed with the support from the Kasson-Mantorville community who joined the Coy's in supporting mental health awareness efforts. The Wyatt M. Coy Memorial scholarship fund was created through community support of the family and the desire to "do something." That something was a memorial snowmobile ride event, which has raised awareness about mental illness and generated funding to create a legacy.

As a nurse, Michelle, uses her profession to advocate for mental illness awareness, screening, and treatment. She has lived through the challenges of finding appropriate mental health care, and is passionate about bringing more professionals to our local community. She also is an advocate for mental health first aid education for teachers, ministry, law enforcement, and community service providers.

"The goal of the scholarship is simple—to end mental illness," says Matt. "Sure, it's a goal that is un-attainable, but we can make progress. We recognize the massive shortage of mental health professionals and the ever-growing need for providers. We hope to continue to grow this scholarship fund to be able to provide four-year scholarship awards."

Wyatt's sister Morgan, in high school and now as a college student at Luther College in Decorah, lowa, regularly talks to her schoolmates about mental illness. She has learned





that it is "ok to not be ok" and she lives out this lesson by talking openly and honestly about mental health with everyone she connects with.

The Wyatt M. Coy Memorial Scholarship is one of 20 scholarship funds managed by Rochester Area Foundation. In 2020, the Foundation, with its scholarship fund holders and education partners, awarded 48 scholarships totaling \$62,000. Scholarship funds provide hope and opportunity for students who desire to pursue higher education. The individuals and families who host these funds have the knowledge that their financial investments are well managed, and that through the volunteer scholarship committee, candidates are chosen who best embody the spirit of the educational award.

Wyatt's caring and empathetic soul lives on through his family. Students who are chosen for the scholarship that bears his name will benefit for years to come as recipients of not only much needed funds to support their education, but also by learning about Wyatt and that "it's ok, not to be ok."

Cain Family

A happenstance provided Thomas and Mary Margaret Cain the ability to leave a generous legacy that will provide support for many nonprofit organizations for years to come.

As a newly married couple in Iowa, Tom and Mary Margaret were starting their life together. Tom had served our country in the Army and had been honorably discharged. He then attended college and mortuary school and was working at a local funeral home. Tom and Mary Margaret were building a life along a path that they had chosen together.

Fate stepped in and their life took a turn when the Cain's became neighbors with Ray Kroc. The Kroc name is synonymous with McDonald's, as Ray Kroc was the founder of McDonald's Restaurants. What started as a neighborly relationship soon became a business partnership, and Tom's career path rapidly changed.

Tom Cain opened his first McDonald's Restaurant in Winona, MN in 1957. All told, Tom owned and operated five

restaurants for almost 40 years. He achieved the highest company honor, the coveted Ray Kroc Award, for his excellence and perseverance for his McDonald's operations. According to Joanne Ott, his longtime business manager, Tom's motto was to be fair but firm. She worked for 30 years with the family in their business, and ultimately became the caregiver and trustee for Tom and Mary Margaret's youngest daughter Cathleen. Joanne remembers the great storyteller Tom was and how he was well-loved by friends and employees. "He was always available to employees if they had questions or problems, and many a time he helped an employee with money if they needed help," Joanne recalls.

Tom and Mary Margaret's generosity was also demonstrated in their volunteer efforts as scout leaders, at Ronald McDonald House, and on the many committee roles that they both held over the years. Tom was also awarded the Knight of St. Gregory Award from the Pope for continued generosity in the Catholic community.

CRISP GOLDEN FRENCH FRIES CREAMY OLD-FASHIONED SHAKE Tom and Mary Margaret's philanthropy continues after their passing with the creation of the Cain Family Donor Designated Fund at the Foundation. This endowed fund will yearly support 12 nonprofit organizations in Rochester, Iowa, and across the country. Jose Rivas, Principal at CRW architecture + design group, was engaged early on with the First Homes program when the staff team brought him a concept to design and build condominium units. Since this first project, Jose has been integral in providing support to the First Homes project on 9th Ave NE and many others.

Jose has continued to work with First Homes and Rochester Area Foundation to address the need for affordable housing in a number of different capacities. Rochester Area Foundation is honored to share Jose's belief that affordable housing is a key ingredient for building a stable foundation for our community. He expresses, "I am proud that part of my legacy in Rochester is for supporting the work of First Homes and Rochester Area Foundation in the development of sustainable solutions to home affordability. Together we are working towards the goal that everyone who calls Rochester home has a safe and dignified home."

First Homes was organized in 1999 and is guided by the mission to provide leadership in the creation of a permanent supply of quality workforce housing throughout the greater Rochester area. This has largely been achieved through the growth of our Community Land Trust. This work is supported generously by community partners, those who understand the

need and importance of collaborative work.

In 2018, Olmsted County Housing & Redevelopment Authority worked with First Homes to acquire land on 9th Ave NE at a very low cost. The structure on the property at the time was a small home originally built in the 1940's. After its owner passed away, the home sat unoccupied for many years and eventually the County took ownership of the property through the tax forfeiture process. This lot provided an opportunity for First Homes to model a new construction single-family home, with an added focus on sustainability. Using sustainable building practices will result in lower long term home maintenance and utility costs for the homebuyer.

Cooperative partner investment in this housing initiative was provided by Maplewood Homes, XRG Concepts, CRW architecture + design group, Minnesota Housing, Coalition for Rochester Area Housing, and Olmsted County. Each organization played an important role to bring this project to fruition as an addition to the Community Land Trust.

We were honored to welcome home the new owner in June 2020 to a beautiful, efficient, single family home.

First Homes Community Impact

Affordable Homes and Rental Units Located in 12 Communities

Planting her garden and spending time on the front porch are two things Emily Osweiler is planning to do at her new home in southeast Rochester. "My favorite spot in the house is the front porch," Emily reflects. As one of the homeowners within the First Homes program, Emily was able to purchase her home and leave rental options behind her. After moving to Rochester and living in Olmsted County supported public housing with her children for 10 years, she was fortunate to meet a family who were living in a First Homes Community Land Trust (CLT) home. The family was planning to move and they suggested that Emily come over and look at their home and contact Shirley Lee, First Homes Program Officer.

Emily recalls the process being very quick after her initial conversation with Shirley, "I think it was about six weeks from my first call to Shirley to closing on my home," states Emily. Shirley comments that "First Homes works to create a home buying experience that is supportive and educational for buyers, with everyone working together to make the home owner successful in their purchase and ultimately have a home to call their own." Emily confirms this sentiment and found that from applying to the program to working with Home Federal to obtain a mortgage, everyone was extremely helpful.

The home that Emily purchased had been divided into two apartments at one time. When First Homes acquired the property, we renovated it through a federally funded program, the Neighborhood Stabilization Program (NSP).

The goal was to once again offer a single-family home, while restoring the original charm of the home and improving the energy efficiency with new appliances and systems. "Relationships are an extremely important piece of our First Homes initiatives," states Jennifer Woodford, Rochester Area Foundation President. "From those who assist with building and remodeling, to our financial partners, we are better together in supporting affordable housing through collaborative work."

Now the Osweiler family has enough space for everyone, including Emily's children who love having their own bedrooms. The kids rooms are all on the second floor, which is now deemed "The Kid's Only Floor" and Emily couldn't be happier about that!




In 2020, First Homes took a stronger position in support of its mission to provide quality and affordable housing by purchasing a rental housing property. Center Street Apartments contains 36, two-bedroom units near downtown Rochester and has rents that are affordable for people under 50% of Area Median Income. First Homes stepped in and made the purchase because the property was being sold and was in danger of no longer having affordable rents. This is the first Naturally Occurring Affordable Housing (NOAH) project that First Homes has undertaken. NOAH units are residential properties that are affordable, but unsubsidized by any federal program. NOAH properties are the most common form of affordable housing in the United States.

First Homes is grateful to many community partners who worked with us to make this purchase possible, including the Coalition for Rochester Area Housing, Olmsted County Housing and Redevelopment Authority, and Greater Minnesota Housing Fund. This is one of the largest NOAH projects in the area to date, and an important step in First Homes' efforts in supporting workforce housing. As the new owner, First Homes is committed to keeping rents at Center Street Village affordable.

"For 20 years, First Homes' vision has been to provide opportunities for low and moderate-income families to secure housing in the Rochester area that is decent and affordable. We are making every effort to realize that vision by preserving an important affordable rental option in Rochester," said Justin Voss, First Homes Program Manager.

A Donor Advised Fund allows an individual or family to make a taxdeductible contribution of appreciated stock, real estate, personal property, or cash when the timing is right for the family. However, the family can then take the time they need to put philanthropy into action by recommending grants to those organizations that support their favorite nonprofits and meet their charitable goals.

With more than 75 years of leadership the Foundation carefully manges funds, advises fund holders of unmet and emerging needs in our community and helps families achieve philanthropic goals.



It's a unique way to give within the community.

For over 25 years, Colin has been a Financial Advisor with Thrivent Financial, and he knows the benefits of providing solid financial advice and planning. Through the relationships he has developed with his clients, Colin believes that sometimes it is best to include conversations about charitable giving. Those conversations have led to some of his clients partnering with Rochester Area Foundation and opening a Donor Advised Fund so that they can fulfill their own philanthropic goals.

The Aldis family is interested in supporting local charities including Quarry Hill, Jeremiah Program Rochester and First Homes. "Watching my parents open their home to others, including family and friends, even though we had a family of 15 under one roof, taught me the importance of helping others," remembers Patricia. Through their Donor Advised Fund, Patricia and Colin intend to do just that—share their good fortune, and their blessings, with others.

"The Housing Alliance provides a forum for public, private, and nonprofit sectors and local housing advocates to share information, ideas, and strategies. The value of the Alliance is growing as a way to identify opportunities for collaboration and collective action to address our area's serious shortage of affordable housing," expresses Olmsted County Commissioner and Coalition Leadership Council Member, Sheila Kiscaden.

Bear Creek Development Center partnered with the Coalition for Rochester Area Housing on an ambitious project to turn the former Crossroads College campus in southwest Rochester into affordable housing. The Coalition awarded a \$354,000 rehabilitation grant and also awarded two additional loans to assist the project in moving forward successfully. A low-interest construction loan of \$500,000 was made, and a deferred loan of \$136,000 was given to help ensure affordability of the new units. The \$136,000 loan has no payments during the first 20 years, and if the units remain affordably priced for households making less than 50% of Area Median Income (AMI) through the year 2040, the loan balance will be forgiven.

The project will create a total of 60 affordably priced units, including 43 rehabilitated units and 17 new studio units created in former educational buildings on the campus. The completed project will be known as Mayowood Acres and the campus design allows for future expansion of affordable housing.

Coalition funded initiatives have a greater rate of success due to the collaboration and the ability to leverage multiple funding sources. According to Jeremy Emmi, Director of the Coalition for Rochester Area Housing, "The Housing Coalition's investment leveraged the creation of new affordable units and rehabilitated many more on a site that commercial builders weren't able to cost-effectively develop before Bear Creek approached the project." Implementing creative solutions to maintain and create affordable housing enables more stability for our residents and the opportunity to be contributing, successful community members.

Founded in 2017, the Coalition for Rochester Area Housing is a collaboration of public and private sector organizations, with funding support from Mayo Clinic, the City of Rochester, Olmsted County and Rochester Area Foundation. The Coalition is a funders collaborative, comprised of thought leaders who seek to address and improve the affordable housing gap in Rochester and area communities.



Since 2018, the Coalition has invested

\$3.8 MILLION

in creating and preserving affordable housing.

These projects have created

\$112 MILLION

in economic development impact for our communities.



With those resources, the Coalition created, preserved, or impacted the affordability of over

648 Units of Housing.



20 Housing Choice Vouchers

were made available to income-qualified members of our community.



This collaboration allowed affordable housing projects to leverage over \$4,699,000 in Tax Increment Financing.



Over \$700,000

will revolve back to the Coalition. Revolving loans allow the Coalition to be sustainable over time.

Looking Ahead...

The Coalition will soon release its five Housing Priorities for Olmsted County, followed by a Housing Blueprint for continued action. These efforts follow the release in November 2020 of the Olmsted County Comprehensive Housing Study.


Grant Cycles

Partnering for greater impact was a theme among our 2020 Spring Grant awardees. Of the thirteen nonprofit organizations who received funding, six applications were projects engaging multiple partners to serve community members with greater impact. Over all, over \$100,000 was awarded to those important initiatives. The fall grant cycle was paused for 2020 as Foundation leadership determined there was great need to support COVID-19 relief funding, and a significant investment was made in the Together Fund that was administered by Rochester Area Foundation.

Throughout the year, Rochester Area Foundation utilized our flexibility to respond to urgent needs and change course when needed to make the best decisions to support our community. In light of the pandemic, all of the nonprofit organizations who received funding within the spring cycle were given the option of using those financial resources for general operating expenses instead of the projects they originally proposed for support.

By partnering with Rochester Area Foundation through an Agency Endowed Fund, we have been able to provide several youth and their families funding to assist with items needed to support treatment goals that would not have been able to be provided in the past.

For more than 50 years, Zumbro Valley Health Center (ZVHC) has worked to improve the health of adults, adolescents and children in SE Minnesota regardless of their ability to pay.

As a community mental health center, the organization enhances the quality of life for individuals through its integrated mental-chemical-medical health programs. The programs and services they provide all have the same goal, helping people with a mental illness, substance use disorder and/or medical condition lead more healthy, productive and self-sufficient lives.

In 2008, ZVHC opened an Agency Endowment Fund at Rochester Area Foundation, to help provide a community safety net, understanding that the annual funding ZVHC receives often is not enough to cover the full cost of services or isn't flexible. Beth maintains, "There are a lot of non-healthcare items that make all the difference for a successful recovery to our clients, and by

having funds with RAF with some flexibility for our team to utilize, that allows us to fill in the other things that are essential for positive mental health and a fulfilling life."

2020 was a challenging year for everyone, and the staff at ZVHC needed to change the way they engaged with clients, pivoting to offer healthcare services in a safe and socially distanced way through virtual telehealth solutions. ZVHC worked with one school-aged client who struggled to sit still via telehealth. Using a tablet to communicate with his therapist was frustrating and became a focus for the client instead of his engagement in conversation. With the flexibility of funds disbursed from ZVHC's endowed fund, the therapist was able to purchase a stand for his tablet so the student could fully engage via telehealth making therapy more effective.

Nonprofit organizations who have established agency endowment funds at Rochester Area Foundation, benefit from creating financial sustainability. RAF experienced staff also assist organizations by helping them accept complex gifts, develop planned giving programs, and provide investment management for funds held at RAF.

Census 2020

Rochester Area Foundation invests in work that convenes stakeholders around community issues and collaboration. In 2020, RAF invested in supporting the 2020 Census because everyone deserves to be counted.

Throughout the year, RAF promoted the benefits and impact to our community and region by higher participation in the 2020 Census. On July 10th, RAF hosted a virtual conversation with Secretary of State Steve Simon on the importance of census participation. RAF also provided funding to our Geographic Affiliates to promote Census work within their communities.

We understand the greater impact we can achieve by engaging our partners and collaborating to lift up community issues and opportunities.

Rochester Area Foundation partners with four regional community foundations to support local philanthropy investments and provide resources for success. This model allow for the local community foundations to invest in impactful projects and initiatives within their communities, while benefiting from Rochester Area Foundation resources, investment management and expertise.

In 2020, our Affiliate partners held over \$849,000 in assets with Rochester Area Foundation for future investments into their communities, creating positive impact.

More Than Just a Building

The impetus for creating an Incubator space when Rochester Area Foundation moved to its current location was to offer nonprofit organizations not only a physical office location, but a collaborative atmosphere. The hope was that by offering nonprofit agencies who were at various points along the path to gaining a nonprofit status an office, they could learn from each other and find kinship.

2020 brought unforeseen opportunity to two of our Incubator residents. Zumbro Valley Medical Society (ZVMS), a professional membership organization for physicians and physicians in training, has been a nonprofit organization since 1934. In 2019, to save on the high costs of rent, telecommunication fees, and parking, the organization moved from its downtown office to the affordable and collaborative Incubator space.

The Ethiopian Community Rochester MN (ECRM), is at the beginning of their journey visioning their nonprofit mission and community impact. Their group of passionate Ethiopians came together to form a community, and created a platform and place for people in the Ethiopian community to support each other,

share experience, and to give back to the community. "We were looking to find a means to bring everyone together, promote our unique heritage, and showcase our cultural integration here in Rochester," states Yitbarek Mirete, ECRM Volunteer.

Due to the pandemic and the inability to gather and bring people together, both groups focused on how they could support our community. ZVMS was looking for ways to assist healthcare workers and initiated a sewing brigade of sorts, making and distributing cloth face masks. Medical students who were not able to get hands-on experience with patients began picking up materials and sewing machines from ZVMS Executive Director Beth Kangas at the RAF Incubator. Seeing firsthand what ZVMS was working on motivated ECRM to partner and offer sewing as a volunteer activity to be able to provide fabric masks to their community members.

Groups working towards a common goal and supporting our collective community is exactly how Rochester Area Foundation leadership envisioned the Incubator space could work, and these two organizations demonstrated a truly fantastic partnership.




