The Rochester Nonprofit Consortium was founded in 2016 as an informal group of nonprofit executive directors interested in finding new ways to work together and create efficiencies for their organizations. Funding from Otto Bremer Trust, Mayo Clinic, and Rochester Area Foundation, as well as guidance by an Executive Committee of nine diverse nonprofits, produced a thriving organization working to develop shared services and resources to increase operational efficiency among nonprofits. In response to the COVID-19 crisis, the Consortium quickly became a hub for cross-sector collaboration on complex issues facing our community.

Today, the Consortium provides a wide array of programming and resources aimed at supporting the diverse nonprofit ecosystem in the Rochester area. In addition to grant funding, the Consortium is supported by nonprofit memberships. Consortium members not only drive programming priorities, but also have access to valuable resources and events. Rochester Area Foundation is committed to keeping the Consortium member-centric and will continue to engage an advisory committee approved by the membership.

We are delighted to provide further support to and strengthen our relationship with the Rochester Nonprofit Consortium," RAF President Jennifer Woodford shares. "RAF's mission is in direct alignment with the mission of the Consortium with both organizations committed to bringing people together to solve complex community problems.
